### The Fair Housing Act states:

It is illegal to discriminate in the sale or rental of housing, including against individuals seeking a mortgage or housing assistance, or in other housing-related activities. The Fair Housing Act prohibits this discrimination because of race, color, national origin, religion, sex, familial status, and disability.

The law requires housing providers to make reasonable accommodations and reasonable modifications for individuals with disabilities. Federal nondiscrimination laws that protect against disability discrimination cover not only residents and home seekers with disabilities, but also buyers and renters without disabilities who live or are associated with individuals with disabilities. These laws also prohibit housing providers from refusing residency to persons with disabilities, or placing conditions on their residency, based on their requirement of reasonable accommodations or modifications.

The prevalence of disability increases with age and around half of people over 75 have a disability. As we age, we increasingly need housing that is affordable, accessible and well located to maintain dignity and quality of life. Even though age is not a protected class, disability is under the Fair Housing Act.

People all over the country have relied on the Fair Housing Act to ensure that they have equal access to housing that is affordable, appropriate and accessible to them, and that provides the services they need in their communities.

## Housing Reminders

CTHC offers automatic rent deductions from checking or saving accounts so you don't have to remember to pay your account every month. If you are not taking advantage of this service and would like to know more about it, please contact your Complex Manager. You can also pay by credit card for a small fee.

Any materials other than domestic sanitary sewer waste are prohibited from entering the wastewater stream. Items that should NOT go down the drain include:



- Towels, gloves, wash cloths, moistened wipes, adult diapers, or similar items.
- Fats, oils, and greases
- Toilet deodorizers that contain wires. These items get stuck and cause backup that leads to overflow. If the toilet is backed up, **DO NOT** continue to flush it.

Residents will be required to clean up the overflow from drains/toilets/etc. If the cause of the overflow is determined to be a result of actions of the residents and/or guests, residents will be charged if maintenance has to unclog sinks/drains/ toilets due to prohibited items.

**B**end Adams and **Raintree** – The pools are open. The pool rules are posted both at the pool and in the Resident

Handbook and Community Policies. It is your responsibility to ensure you, your household members, and your guests follow the pool rules. Remember that the Pool Monitor is an employee of the Central Texas Housing Consortium, and it is her responsibility to monitor safety in the pool and make sure the pool rules are being followed. Failure to follow the rules, and failure to do what the Pool Monitor asks of you, is a violation of your lease and can be grounds for suspension of your pool privileges.
